I. Purpose:

High School Articulation allows high school students to earn college credit as they build career and technical education (CTE) skills and awareness of Pikes Peak State College's (PPSC) CTE programs. A high school student can receive PPSC credit if they earn an A or B in their high school course(s) approved by the college. Articulated credit and coursework will be recorded as High School PLA Credit on a Pikes Peak State College transcript.

II. Scope:

High School Articulation is a partnership between Pikes Peak State College and area High Schools.

III. Procedure:

A. APPROVING ARTICULATION CREDIT

- High school faculty or administration request courses for inclusion into the High School Articulation program. Courses must be part of a Colorado Community College System (CCCS) approved CTE program taught by a faculty with corresponding CTE credentials.
- A college department chair or designee approves courses that meet 100% of the course outcomes of the college course(s) to which it articulates.
- Agreements for course articulations are valid for three years with annual confirmation by the high school that the course curriculum and CCCS program approval have been maintained.

B. AWARDING ARTICULATION CREDIT

- The college will allow nine (9) college credits to be awarded through High School Articulation. Additional credits earned through High School Articulation can be awarded after completion of at least one for-credit course at PPSC.
- Credit for Articulation must be earned by completing an approved class with an A or B grade in course(s) that were approved at the time of course enrollment and completion at the high school the student attended. The grade and course must be verified by the high school instructor, registrar, or administrator or an official or unofficial high school transcript.
- Students must request credit within three years of completing the articulated course.
