

PPSC International Student Housing Sponsor Information

Housing Sponsors must provide the following:

- 1. Notarized Sponsorship letter: the template is included on the next page.
- 2. Copy of deed or mortgage statement to the residence that the student will be residing, in the name of the housing sponsor.

If the property is rented and not owned by the housing sponsor, the housing sponsor may provide a copy of a lease with either the student listed as an approved occupant (not as a tenant that owes rent), or a lease and a statement from the property management company/landlord clarifying that the student will be residing at the property and will not owe funds for residing there.

 Please note: A <u>lease</u> must cover the <u>entirety</u> of the student's first academic year of their program. Otherwise, monthly housing funds of \$1,165/month must be shown in bank statements for the months that the lease does not cover.

For example, if a student begins their academic year in August, and the academic year is from August – May (9 months) but their housing sponsor's lease ends at the end of March and they do not plan to renew, they must show two months in estimated housing expenses to cover the full academic year including April through May $($1,165 \times 2 = $2,330 \text{ additional required funds})$
