This form must be submitted by all F-1 students want to apply for admission or change program level at Pikes Peak State College (PPSC). Verification of financial resources are required for F-1 visa student admissions.

Students must submit the following in addition to pages 1 and 2:

- **Bank Statement(s):** Printed on bank letterhead and/or stamped/signed by bank official. Must be dated within past 6 months. Financial document requirements are listed on page 2.
- **Signed Financial Affidavit** on page 3 *(If student has a financial guarantor)*
- **Notarized housing sponsor letter** on page 6 **and** copy of **deed, mortgage statement or lease granting permission** for the student to live at the property *(if student has housing sponsor in Colorado Springs)*.

- Are written in English (or officially translated into English); If the document is not in English, the original document must be submitted with the official translation.
- Include the account holder's name.
- Are printed on professional letterhead stationery and contain the bank's official stamp or seal.
- State the type of currency **and** the specific amount that is currently available in the account or state the amount of funds on deposit.
- Are dated within the last 6 months at the time the I-20 is issued.
- Are accompanied by each guarantor's affidavit of support on the Financial Information section if documented funds are not in the student's name.

PPSC WILL NOT ACCEPT THE FOLLOWING DOCUMENTS AS PROOF OF FINANCIAL SUPPORT

- Wage statements
- Retirement funds
- Investment Accounts
- Copy and pasted screenshot of bank statements
- Any non-liquidated sources of funds

I, the Student, understand and agree:

- I must be officially admitted to the college and provide acceptable financial documents before an I-20 can be issued.
- This information is a true reflection of my intended sources of sponsorship while attending PPSC
- If I do not pay all tuition and fees on time, my classes may be cancelled, and my visa status will be terminated. If this happens, I must leave the U.S. immediately.
- If my sponsor can no longer sponsor me financially, I am required to self-pay to remain enrolled.
- Students in F-1 status may not become a financial burden to the U.S. or its institutions.
- I will need to provide new financial documents if
 - I must update my application to a later semester
 - Extra time is needed on my I-20 for me to complete my current program of study
 - If I pursue another program of study (example: ESL to Associates)
- I can be expelled from the college for providing false information on my application or related materials.

By signing below, I acknowledge that:

- My failure to pay tuition and fees on time may result in the student not being allowed to attend classes
- Students who do not attend classes during fall or spring semesters are in violation of the law (or summer semester if summer is the student’s first term). This will result in the student’s visa status being terminated and the student being required to leave the U.S. (subject to deportation).
- Expenses may increase each year.
- Official documentation of funds on deposit equal to or greater than the estimated expenses for the first year is required for the issuance of an I-20.
- Separate documentation of funds must be provided to the student for visa issuance and/or admission to the U.S.
- If the funds documented are from a business, a letter from the business is required that states business funds will be used to provide support for the student’s educational and living expenses
- If I am providing room and board to the student in my home during their studies, I must provide a notarized letter of support **as well as** a deed, mortgage statement, or lease granting permission for the student to live at the property. If the lease does not cover the entire first academic year of the student’s program, they must show an additional amount of estimated housing expenses totaling however many months the least doesn’t cover.

PPSC International Student Housing Sponsor Information

Housing Sponsors must provide the following:

1. **Notarized Sponsorship letter with the following information: (Students may use the template included on the next page)**
2. **Copy of deed or mortgage statement to the residence that the student will be residing, in the name of the housing sponsor.**

If the property is rented and not owned by the housing sponsor, the housing sponsor may provide a copy of a lease with either the student listed as an approved occupant (not as a tenant that owes rent), or a lease and a statement from the property management company/landlord clarifying that the student will be residing at the property and will not owe funds for residing there.

- Please note: A **lease** must cover the **entirety** of the student's first academic year of their program. Otherwise, monthly housing funds of \$1,400/month must be shown in bank statements for the months that the lease does not cover.

For example, if a student begins their academic year in August, and the academic year is from August – May (9 months) but their housing sponsor's lease ends at the end of March and they do not plan to renew, they must show two months in estimated housing expenses to cover the full academic year including April through May ($\$1,400 \times 2 = \$2,800$ additional required funds)

Keep in mind that in instances where PPSC is not able to verify documents for sufficient funding, PPSC may request housing funds be documented with bank statements or that documents are sent to us from the bank/institution directly. We may ask for this at any time during the admissions process. **Submitting falsified bank documents or submitting bank statements with funds that are not intended for the student's use is considered visa fraud and could result in permanent visa ineligibility by the U.S. government.**

- A deed, mortgage statement, or lease with landlord approval must be submitted along with this letter to show jurisdiction of the property.
- Failure to provide housing may result in the student not being able to attend classes and may result in a visa status violation. Students that violate their visa status will have their SEVIS record terminated and the student will be required to leave the U.S. immediately (subject to deportation).
