HOW TO COMPLETE EDREADY TO PLACE INTO COLLEGE-LEVEL CLASSES

1. Create an account in PPCC's EdReady Platform: ppccedready.org
 - Students must use their PPCC assigned student email if they have one. If you do not have a PPCC email, you should use the email you included in your PPCC application.
